§ 1 General requirements

The BSc programs at the Faculty of Environment and Natural Resources Freiburg require a practical training period (internship/work experience) of at least 8-weeks in accordance with the examination regulations for the degree program Bachelor of Science (annex specific regulations § 4). For the internship/work experience, students will work in institutions and companies outside the Faculty or in research institutes of the Faculty

- 1. According to § 6 paragraph 1 of the examinations regulations of the University of Freiburg for the B.Sc. degree program, in connection with § 3 annex B. III. for 'Geography' (main subject), 'Environmental sciences' (main subject) and 'Forestry and Environment' (main subject) students are obliged to do internship/work experience during the duration of their degree program.
- 2. The minimum duration of the total internship/work experience is eight weeks. The internship/work experience can be divided into different parts. Each part must last at least four weeks. The supervision of the internship/work experience is the responsibility of the internship/work experience provider.

§ 2 Duration of the practical training

- 1. The internship/work experience lasts from to (= weeks)
- 2. The regular number of weekly working hours is to be equivalent to that of a full time employee.

§ 3 Duties of the practical training provider

The internship/work experience provider is required to fulfil the following obligations:

- 1. Offer the student training and supervision during the internship/work experience period in accordance with the training schedule. The internship/work experience schedule is part of this contract.
- Include the student in the employer's group insurance to cover general accidents; if this
 is not possible, the internship/work experience provider informs the student and recommends to obtain his/her own liability insurance.
- 3. Notify the Faculty of Forest and environmental Sciences, if the contract is discontinued before the end of the contract.
- 4. Issue a confirmation of the successful completion of the internship/work experience according to annex 3 'internship/work experience certificate'.

§ 4 Duties of the student

The student agrees to.

- 1. Make use of the offered training opportunities,
- 2. Fulfil all assigned tasks reliably <u>and</u> comply with instructions given within the scope of the practical training,
- 3. Comply with the policy of the internship/work experience placement, as well as the health and safety regulations. Machines and equipment must be handled with care,
- 4. Comply with the interests of the internship/work experience placement and any confidentiality clause,

5.	Notify the internship/work experience provider immediately about any absence from work, and, in case of incapacity for work as a result of illness, to submit a medical certificate on the third day of the absence at the latest. Absences of more than 5 days have to be compensated through a prolonged internship/work experience period.
