Opening of the university buildings

Dear Members of the Faculty,

As you may know, the Rector announced that the study operations of the University of Freiburg are no longer suspended and instead operating under precautionary pandemic conditions.

Accordingly, the electronic access system for the university buildings has been set back to normal operation since Monday, July 27th. **Currently, access is only permitted to university members and employees of commissioned external companies.** All university buildings are closed to the public until further notice.

The following hygiene and safety regulations must be strictly observed when using University facilities:

- Wearing a face mask (in all corridors, staircases, toilets and elevators)
- Maintaining a minimum distance of 1.5 meters from other persons
- Compliance with hygiene rules
- No gathering in groups

All lecture rooms in the faculty buildings will remain locked and all seating in the open areas and foyers of the Herderbau has been removed. For approved events and exams, individual Department Chairs and their Heads as well those individuals directly responsible for the event or exam are responsible for compliance with regulations and arranging the opening and locking of rooms. It is not permitted to gather outside rooms and in lounge areas in the Herderbau. This explicitly includes the covered inner courtyard.

Specially marked workstations near the faculty library (Herderbau) will be set up for students in the coming days, including 12 computer workstations in CIP 2 (1st floor). The use and reservation of these will be carried out by the library under the following link:

The Dean's Office is working on setting up additional workstations for students for the winter semester 20/21.

The Dean's Office, the Examinations Office, and program and consultation offices will continue to operate via email and telephone during opening hours. No in-person consultation hours are possible at this time. We recommend that the faculty departments keep their offices closed to drop-in and consultation
